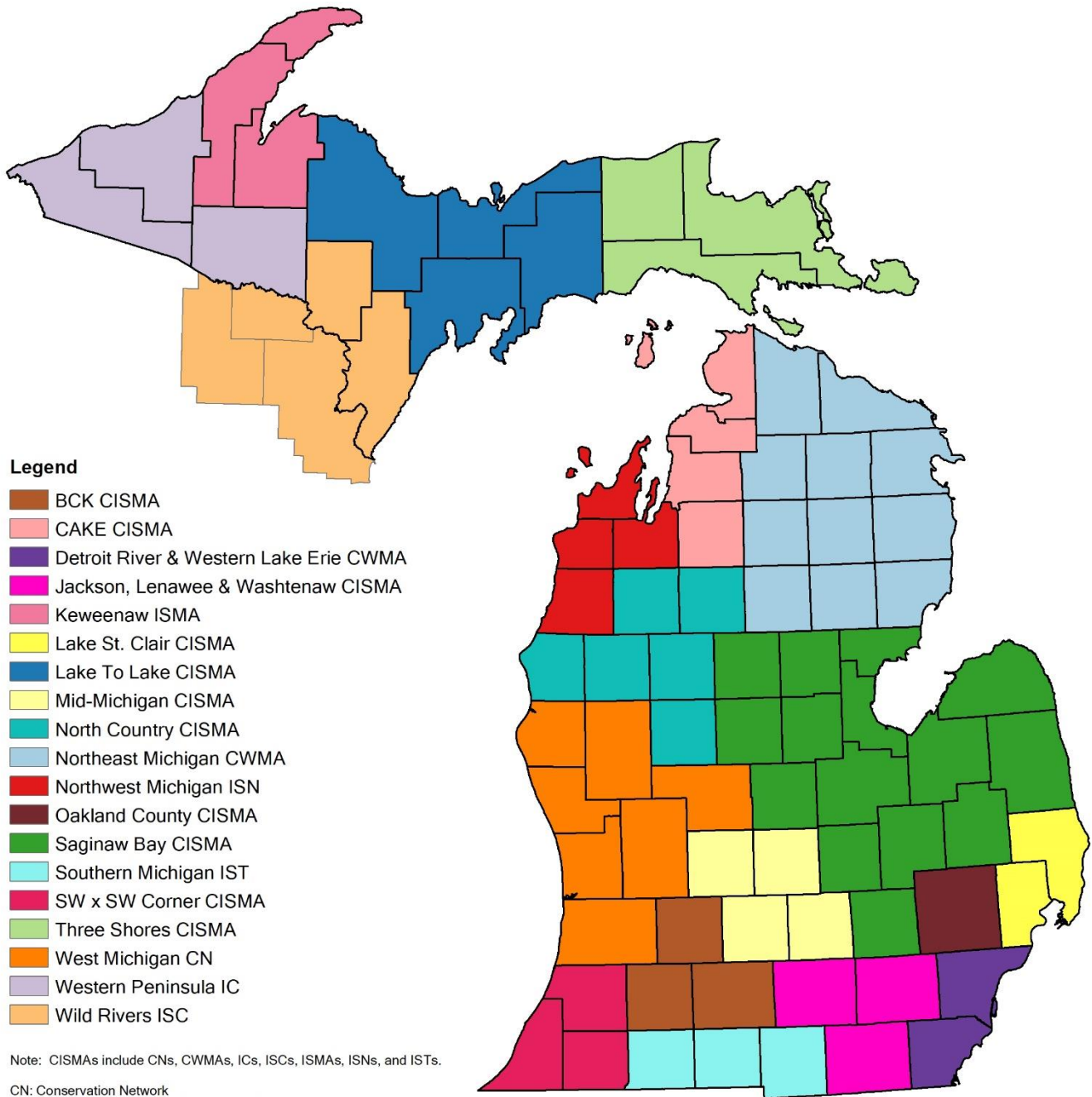


Michigan Cooperative Invasive Species Management Areas
